# **NEF Expansion Funding**

From 2<sup>nd</sup> January those parents that are eligible for phase one of the 2 year old National Education Funding will be able to apply. Please keep in mind however that this funding will be able to be used in settings (subject to availability) from 1<sup>st</sup> April.
